Management Report on Fund Performance

Results of Operations

For the six months ended June 30, 2015, the net asset value of the Fund for pricing purposes was \$13.87 per unit compared to \$13.72 per unit at December 31, 2014.

For the six months ended June 30, 2015, the fund had a positive return of 3.39% net of fees and expenses of 1.64% while the DEX Universe Bond Index had a return of 2.37%. Declining global growth continues to attract assets into the fixed income market. The strategy of the Fund has been to overweight corporate bonds relative to its benchmark as yields represent value relative to Government bonds. Term to maturity was also longer than average, which enabled the Fund to produce positive results.

The Fund may utilize various forms of borrowings including a loan facility and margin purchases, up to 35% of the total assets of the Fund at the time of the borrowing. Accordingly, the maximum amount of leverage that the Fund could employ is 1.54:1. Ridgewood, in its capacity as trustee of the Fund, established a margin account with The Bank of Nova Scotia ("Scotia") on January 29, 2010. The Fund is required to pay interest to Scotia on any outstanding indebtedness. Such indebtedness is collateralized by a security interest in the portfolio of investments.

As at June 30, 2015, \$66,223,868 of the Fund was leveraged. During the six months ended June 30, 2015, the Fund's maximum leverage outstanding was \$74,559,008 and the minimum leverage outstanding was \$50,530,021.

Recent Developments

The first half of 2015 was positive for bond investors as returns outpaced U.S. and Canadian equities. Declining inflation and modest growth has been an attractive backdrop for fixed income investors as money flowed into investment grade and high yield asset classes. Corporate bonds are performing well in this environment as the additional yield over Government bonds makes them more attractive. Refinancing of existing and maturing debt has been slightly above average which is positive for liquidity. The supply will likely moderate in the second half which will push bond prices higher as demand continues to be robust.

The Bank of Canada has cut rates 25 basis points in the first half of 2015 and they continue to be accommodative. Although the U.S. economy continues to grow steadily, small cracks are appearing not only in Europe but China as well. The Greek situation continues to unfold and we have not seen the final resolution. This has kept central banks globally still on deflation watch for the most part, although the risk of that in North America is quite low.

Information for the years ended December 31 is derived from the Fund's audited financial statements, with the exception of 2013 information, which was re-stated in accordance with IFRS requirements. For June 30, 2015 and December 31, 2014, the Net Assets included in the Net Assets per Unit table is from the Fund's unaudited and audited financial statements, respectively, and are calculated using closing prices while the Net Asset Value included in the Ratios/Supplemental Data table is for Fund pricing purposes and calculated using closing prices. All other calculations for the purposes of the MRFP are made using Net Asset Value.

⁽¹⁾ This information is derived from the Fund's unaudited financial statements as at June 30, 2015 of the period and the Fund's audited annual financial statements as at December 31 of the year, with the exception of 2013 information, which was re-stated in accordance with IFRS requirements. For all prior years the financial statements of the Fund were prepared in accordance with Canadian GAAP applicable to public enterprises. Class A units list their initial offering price of \$12.00 per unit as the opening net asset value although such units may not have actually been issued at the beginning of the year. The inception date for Class A units was December 18, 2009.

⁽²⁾ The net assets per security presented in the financial statements differs from the net asset value calculated for Fund pricing purposes. An explanation of these differences can be found in the notes to the financial statements.

⁽³⁾ Net assets per security and distributions are based on the actual number of units outstanding at the relevant time. The increase (decrease) from operations is based on the average number of units outstanding over the financial year.

⁽⁴⁾ Distributions, if any, were paid in cash, reinvested in additional units of the Fund, or both.

⁽⁵⁾ The Financial Highlights are not intended to act as a continuity of the opening and closing net assets per unit.

⁽³⁾ Management expense ratio is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net assets during the period. Out of its management fees, the Manager pays for such services to the Fund as portfolio manager compensation, service fees and marketing. Management expense ratio is inclusive of performance fees.

⁽⁴⁾ The Manager, at its discretion, waived and/or absorbed a portion of the fees and/or expenses otherwise payable by the Fund. The waiving and/or absorption of such fees and/or expenses by the Manager may be terminated at any time, or continued indefinitely, at the discretion of the Manager.

⁽⁵⁾ The Fund's portfolio turnover rate indicates how actively the Sub-Advisor trades the Fund's portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher the Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.

⁽⁶⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

Management Fees

Ridgewood Capital Asset Management Inc. (the “Manager”) is entitled to an annual management fee payable out of the assets of the Fund. The maximum management fee is equal to 0.50% (excluding HST) of the net asset value of the Fund. The Manager receives a fee based on the NAV of the Fund’s units, accrued daily and payable monthly out of the assets of the Fund. Services received under the Declaration of Trust include managing or arranging for the management of the Fund’s investment portfolio and providing or arranging for all required administrative services to the Fund.

The past performance of the Fund is set out below and indicates year-by-year returns and overall past performance.

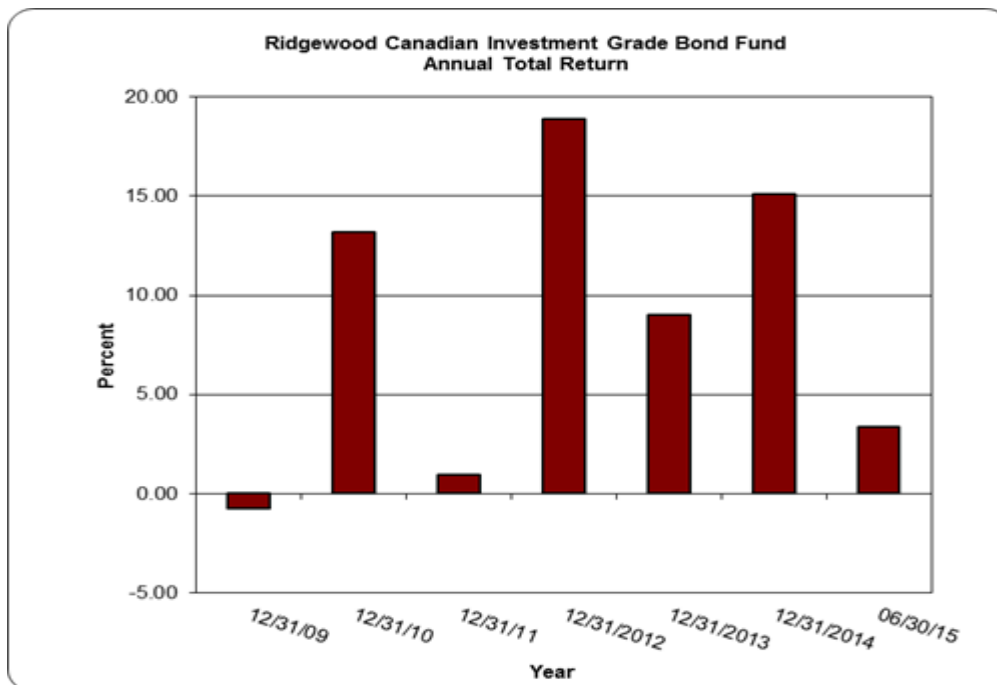

Independent Review Committee
