Ridgewood Canadian Investment Grade Bond Fund Completes Private Placement of Units on March 8, 2018

TORONTO (March 8, 2018) – Ridgewood Capital Asset Management Inc. is pleased to announce today that Ridgewood Canadian Investment Grade Bond Fund (the “**Fund**”) (RIB.UN: TSX) has completed its previously announced private placement of 148,572 units of the Fund (the “**Units**”) at a price of \$14.14 per Unit for gross proceeds of approximately \$2.1 million (the “**Offering**”). The Offering has been conditionally approved by the Toronto Stock Exchange (“**TSX**”), subject to the satisfaction of the conditions of the TSX.
