Management Discussion of Fund Performance

Results of Operations

For the six months ended June 30, 2020, the net asset value of the Fund for pricing purposes was \$9.03 (class A) and \$9.26 (class F) per unit compared to \$9.56 (class A) and \$9.74 (class F) per unit at December 31, 2019.

For the six months ended June 30, 2020, the fund had a return of -3.13% net of fees of 1.47% (annualized) while the FTSE Canada Universe Bond Index had a return of 7.53%. Returns across all sectors were strong as interest rates and inflation remain low for the foreseeable future. Given overall volatility, investors have been favoring fixed income investments over equities. Due to the COVID-19 induced economic contraction, zero bound Government rates will continue to make corporate bonds the alternative for those looking for higher interest. The Bank of Canada will likely be on hold for the next 1-2 years at a minimum.

Recent Developments

It was a very positive first half of 2020 for bond investors. Returns across all sectors were strong as global central banks started to support the market via direct open market purchases because of the COVID-19 crisis. In particular, the U.S. Federal Open Market Committee led the process and was aggressive with their investments. The purchases included investment grade and high yield ETF's as this part of the market was becoming strained at the peak in the first quarter. Corporate bonds continue to perform well in this environment as they provide an additional yield over very low yielding Government bonds.

Financial Highlights

Information for the six months period ended June 30, 2020 is derived from the Fund's unaudited financial statements, while information for the years ended December 31 is derived from the Fund's audited financial statements. The Net Asset Value in the Net Assets per Unit table as at June 30, 2020 is from the Fund's unaudited financial statements, while the ones as at December 31 of the past years are from the Fund's audited financial statements. Calculations for the purposes of MRFP are made using Net Asset Value. The Net Asset Value in the Ratios/Supplemental Data table is for fund pricing purposes. Both the Net Asset Value in the Net Assets per Unit table and in the Ratios/Supplemental Data table are calculated using closing prices.

Net Asset Value per unit is the difference between the aggregate value of the assets and the aggregate value of the liabilities divided by the number of units then outstanding. The valuation of securities are made using closing prices.
- (2) Total increase (decrease) from operations consists of interest revenue, realized and unrealized gains (losses), less expenses, and is calculated based on the weighted average number of units outstanding during the year (period). The schedule is not intended to total to the ending net assets as calculations are based on the weighted average number of units outstanding during the year (period).
- (3) Distributions to unitholders are based on the number of units outstanding on the record date for each distribution and were paid in cash.

(1) This information is provided as at June 30 of the period and December 31 of the year shown.

(2) Management expense ratio is the ratio of all fees and expenses, including harmonized sales taxes but excluding transaction fees charged to the Fund to the average net assets. It is expressed as an annualized percentage of daily average net assets during the period.

(3) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year (period). The higher a Fund's portfolio turnover rate in a year (period), the greater the trading costs payable by the Fund in the year (period), and the greater the chance of an investor receiving taxable capital gains in the year (period). There is not necessarily a relationship between a high turnover rate and the performance of a Fund.

(4) Net Asset Value per unit is the difference between the aggregate value of the assets of the Fund and the aggregate value of the liabilities and including the valuation of securities at closing prices divided by the number of units then outstanding.

(5) The trading expense ratio represents total commissions and other portfolio transactions costs expressed as an annualized percentage of daily average net asset value during the period.

Management Fees

Ridgewood Capital Asset Management Inc. (the "Manager") is entitled to an annual management fee payable out of the assets of the Fund. The maximum management fee is equal to 1.25% (excluding HST) for Class A and 0.35% for Class F of the weighted average net asset value of the Fund less ordinary expenses of the Fund. The fee is accrued daily and payable monthly out of the assets of the Fund. Services received under the Master Declaration of Trust include managing or arranging for the management of the Fund's investment portfolio and providing or arranging for all required administrative services to the Fund.

Past Performance

The past performance of the Fund is set out below and indicates year-by-year returns and overall past performance.

- the returns or performance information shown assumes that all distributions made by the Fund in the periods shown were reinvested in additional units of the Fund;

Year-By-Year Returns

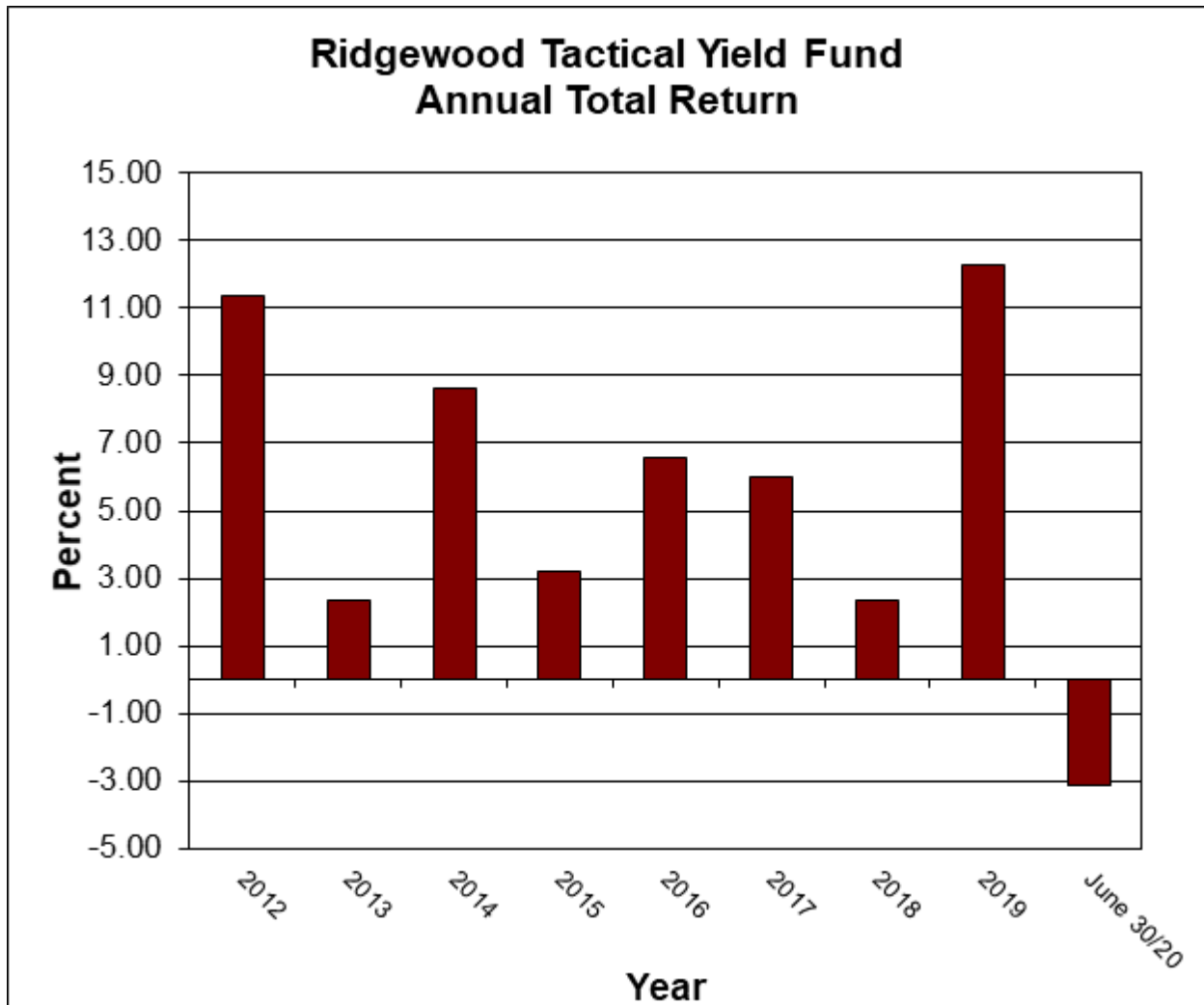

National Instrument 81-107- Independent Review Committee for Investment Funds ("NI 81-107") requires all publicly offered investment funds to establish an independent review committee ("IRC") to whom the Manager must refer conflict of interest matters for review or approval.
